

# At a glance: New CII Diploma in Regulated Financial Planning

This new qualification has been created to meet the new FSA exam standards (QCF Level 4) in full. It fully reflects feedback and discussion with the market with regards to the format, availability and testing methodology.

### The Diploma:

- Is suitable both for new entrants and experienced advisers seeking to upgrade to Level 4
- Requires 6 units to be completed, covering:
  - (R01) Financial services, regulation and ethics
  - (R02) Investment principles and risk
  - (R03) Personal taxation
  - (R04) Pensions and retirement planning
  - (R05) Financial protection
  - (R06) Financial planning practice
- Offers year-round entry and completion
- Is examined through a combination of multiple choice (units R01–R05), available all year round, and a written exam (unit R06) available six times a year
- Delivers comprehensive exam feedback
- Requires no qualification gap fill
- Makes holders eligible for DipPFS status

**Note:** Unit (R01) Financial services, regulation and ethics will become the new licence to give advice under supervision until such time as the full Diploma has been completed.

- (CF3) Financial protection [(R05) Financial protection]
- (J08) Financial planning practice [(R06) Financial planning practice]

## Study support
