# **CII Exam Revision Courses – Questions & Answers**

#### Who should attend these revision workshops?

Anyone studying for the CII exam units covered will benefit. You should have completed most of your study before attending however, as these workshops cannot replace your own study for the exam.

### How much is a place on the revision course?

Costs vary depending on which course you want to book.

Typically, a two-day course costs between £269 and £299 for CII Members / £319 and £349 for non-members.

A one-day course costs between £199 and £219 for CII Members / £249 and £259 for non-members.

### Who are the trainers? Are they any good?

We are working in collaboration with L&D Digital Solutions (L&DDS) to provide this training for you. They are one of the UKs leading providers of CII exam training. L&DDS are well known to the CII and the PFS and have been training R0 and AF exams for many years with great success. As well as delivering live training courses, they also create video summaries for our R06 and AF5 exam case studies, produce video-based training course and mock exams.

### When should I attend in relation to sitting the exam?

We would suggest attending this exam around a week or two before sitting your exam.

#### Will I be disadvantaged by being part of a pilot? Should I wait for the full programme?

Absolutely not. While this is a pilot for the CII, the training content you will receive is tried and tested and has been refined over many years. With any pilot, there may be aspects that aren't as smooth as you would like as a customer. If there are, we really hope you tell us about that in the evaluation, so we can learn and make the necessary improvements.
