## Martyn's Law: Terrorism (Protection of Premises) Bill:

#### May 22<sup>nd</sup>, 2017

Manchester Arena Attack. 22 Victim fatalities, including Martyn Hett.

1,017 non-fatally injured victims.

#### May 2023

Draft Terrorism (Protection of Premises) Bill published.

Proposed scope of Bill includes Standard and Enhanced Tier Groups.

Pre-Legislative scrutiny takes place, via Home Affairs Select Committee (HASC).

#### November 2023

Bill included in King's Speech at the State Opening of Parliament

#### March 18th, 2024

Public consultation closed. The bill will be introduced as soon as parliamentary time allows.

Manchester Arena Inquiry Volume 1 (Sir John Saunders) criticises the lack of a duty to identify and mitigate the risk of terrorism at public venues, to provide adequate protection to the public



Pre-Legislative Scrutiny concludes. HASC report published, with recommendations for improvement.

July 2023

6-week public consultation on an updated approach to the Standard Tier Group begins.

Pool Re, with the ABI, submitted a response to the public consultation.

February 05th, 2024



At this stage there is **no formal legislation**, and all assumptions are based upon the draft and current revisions; the details are therefore subject to change.

#### What are Standard Tier Premises?

- ✓ Be a qualifying activity e.g. retail, entertainment, leisure, places of worship, education.
- ✓ Have a capacity of **100 to 799 people**.
- $\checkmark$  Have a defined boundary.

#### What are Enhanced Tier Premises and Events?

- ✓ As per standard tier premises, but with a capacity of over 800. No upper threshold.
- Qualifying events are as per standard tier premises, with a capacity of over 800, with express permissions for entry; this could be a standard tier premises that holds an event e.g. a place of worship.



#### **Expected** compliance requirements.

#### Standard Tier Premises: Expected to provide proportionate processes to respond to a terrorist attack:

- Notify the Regulator (TBC) that they are, or have become, responsible for premises within the scope of the Bill (and so subject to the relevant requirements).
- Have in place such procedures that may be expected, so far as reasonably practicable, to reduce harm to the public and staff at the premises in the event of a terrorist attack, including evacuation, invacuation, lockdown and communication.
- ✓ It is not expected or required that physical alterations be undertaken, or additional equipment purchased for Standard Tier premises.

#### **Enhanced Tier Premises and Events:**

- ✓ Complete an Enhanced Terrorism Risk Assessment, identifying the relevant threats and taking proportionate mitigation steps.
- Produce, maintain, rehearse and exercise a dedicated Security Plan, including reasonably practicable measures to reduce the risk of terrorism acts occurring onsite, and reducing the potential harm if they were to occur.
- ✓ Provide terrorism protection training for relevant workers.
- ✓ Designate a Senior Officer in charge for the implementation of Martyn's Law requirements at the premises or event.



The provisions for Martyn's Law are expected to drive an increased demand for qualified people, capable of assessing CT threats to workplaces and implementing suitable mitigations. In progress:

#### **Competent Person In the Workplace (CPIW):**

- ✓ National Counter Terrorism Security Office (NaCTSO) designed and endorsed OfQual Level 3 Qualification.
- ✓ Will provide knowledge and capacity to create suitable Counter Terrorism Risk Assessments.
- ✓ Aimed at those making or implementing security decisions within a business.

#### **Counter Terrorism Security Specialist Register (CTSSR):**

- ✓ NaCTSO managed register of Specialists, for organisations that don't have a CPIW.
- Registrants will need to have provided proof that they are suitably qualified, knowledgeable, and experienced as CT Security Specialists.

#### Security Governance Standard, and Certification:

- ✓ National Protective Security Authority (NPSA) designed and managed initiative, in collaboration with the Institute of Directors (IoD).
- Aimed at Company Directors, Non-Executive Directors and Members of a Board.
- ✓ Will allow holders to demonstrate a strategic and auditable understanding of security risks, security risk governance, and the responsibilities of a Board, including potential legal obligations under any forthcoming legislation (Martyn's Law).

## MARTYN'S LAW HUB

The Terrorism Protection of Premises Draft Bill is expected to be introduced for parliamentary scrutiny during the spring of 2024, after the government included the legislation within the Kings Speech (7 November 2023) outlining intention to progress the legislation known as Martyn's Law. This legislation, and the changes it brings, will enhance the protection of the United Kingdom's publicly accessible places from terrorist attacks and help to ensure that businesses and organisations within scope are adequately prepared to deal with the terrorism threat.

This hub aims to provide owners and operators of all such locations information and guidance to help better understand the risks and consider appropriate mitigations.
